In November of 2017, Councillor Andrew Knack once again reintroduced a motion to explore the possibility of using Private Ride Share Companies under the Transit Review.

The City was supposed to come back to the Urban Planning Committee on April 17, 2018 with a recommendation to Council as to whether or not they recommend using Private Ride Share Companies.

Since November of last year, I have been lobbying City Councillors drumming up support to vote against using Private Ride Share Companies. The Union has also obtained a legal opinion from Nugent Law which states under our labour certificate that ATU 569 members are to be the sole providers of collection of transit fares through out the City of Edmonton.

## Automation or Customer Service? You Won't Get Both

**Councillor Andrew Knack has been** in the news recently pushing for Edmonton to be the Canadian Testing Zone for driverless cars and for use in our Transit System. This is right on the heels of a fatality in Arizona (a state known for minimal regulation that companies go to when they want to test their new equipment) where a driverless car struck and killed a woman walking her bike across the street at a clearly marked crosswalk. The technology clearly has a long way to go, and Edmonton's citizens shouldn't be the guinea pigs endangered while it develops.

When a human driver makes a mistake behind the wheel and harms someone there are consequences and accountability for the individual. What happens when a driverless car or bus kills a family member? This is a quote from Uber after the death in Arizona

Uber's CEO, tweeted: "Some incredibly



sad news out of Arizona. We're thinking of the victim's family as we work with local law enforcement to understand what happened."

"The robot cars cannot accurately predict human behavior, and the real problem comes in the interaction between humans and the robot vehicles," John M. Simpson, privacy and technology project director with Consumer Watchdog.

There is so much talk of Public Safety that we make hundred's of 30 km playground and school zones to protect our children, yet in the next breath Councillor Knack proposes the idea of driverless cars driving through these same neighbourhoods. You can't have it both ways, if you're for the safety of your citizens you can't be for testing driverless technology on the streets of Edmonton. I'm not willing to lose a single life to test a new technology.

Automation is not all bad, and in some cases, it makes our day to day lives easier. But who benefits the most from Automation? Private business' do, they reduce their costs by cutting staff and benefits and replacing them with software or equipment. How many of us miss the days of calling our bank and talking to a human being when needing customer service? I know I get frustrated when I have to go through six different menus on my phone and then I'm put on hold because they

have reduced their staffing levels and the software can't handle the number of calls coming in. This is not good Customer Service and we the public do not benefit from it. Sure, the bank saves money, but do we? No, and it's the same for the City. The service levels will drop but we will keep on paying the same taxes even though we no longer get the service we deserve.

If this spreads to your Public Transit service with driverless buses and trains. what will be the effects? Who are you going to ask for directions? Who is going to assist your grandmother boarding the bus during a blizzard? Who is going to call for help when a medical condition occurs or someone is assaulted on the train? Then if you have a problem with your Transit experience you can call 3-1-1 (hopefully you get an Operator and not an Automated menu) and have it looked into and be notified of the results.

The City of Edmonton has to be fiscally responsible to us the taxpayers. At the same time, we have to ask how do we benefit from the changes proposed? Will our transit system be better with driverless vehicles and outsourced to private companies like Uber? Public service has to be provided to it's citizens. The Public Service provided also needs to provide great customer service and you don't get that with Automation.

It is already 17 months working in the position as a Vice President Maintenance, Assistant Business Agent for Local 569 which day by day I am putting all my knowledge, skills and experience to represent members in their best interest making sure wages, hours of work, fringe benefits and working conditions are covered for all our members.

The process to correct things take place little by little but the results are reflected positively in the system. Your patience, understanding, information and feedback, allow me to work harder with good elements in any particular matter.

Fleet Service Department had a title for some members, for a long time, as Service Trained Cleaners which never existed in the Collective Agreement. This issue is fixed and followed up as our Collective Agreement indicates.

The topic of Sign Up is slowly rectified in all the Maintenance Departments Transit Utility Workers, such as: Maintenance Repair Worker, Track

Maintainers, Facility Maintainer, Mechanics, Service Persons, Cleaners, Foremen, Stores Coordinator, Tech I, Tech II, etc.. There are so many aspects to discuss items, following up the mechanism and procedures which take time to resolve. I am working daily on this and the outcome is categorical. As an example, Corporate Service Parts Department members are now able to sign any facility they want based on their seniority. For years they could not do that.

In Fleet Services, seniority is back in recognition as the Collective Agreement is written. Two Relief Service Foremen were placed based on Seniority.
